Re: Deceptive trade practices in marketing and sale of certain "Plum Organics" brand food products for babies and toddlers

Dear Mr. Grimmer and Ms. Morrison:

The Center for Science in the Public Interest ("CSPI") and our co-counsel Michael Reese and George Granade of Reese LLP, have identified that Plum Inc., doing business as Plum Organics ("Plum"), a unit of Campbell Soup Company, is engaging in deceptive practices in the marketing, labeling, and sale of its "Plum Organics" brand food products for babies and toddlers (the "Products," defined below). This letter details our findings and offers to discuss resolution before CSPI and Reese LLP take further legal action. Ultimately, if litigation becomes necessary, CSPI and Reese LLP will seek an injunction prohibiting Plum from expressly or implicitly making deceptive representations on the labels and in the marketing of the Products. CSPI and Reese LLP may also seek corrective advertising, restitution, damages, disgorgement, and attorneys' fees.

The "Products" at issue are the following "Plum Organics" brand food products:

- Plum Organics Blueberry, Parsnip & Buckwheat Organic Baby Food;
- Plum Organics Mango, Carrot & Greek Yogurt Organic Baby Food;
- Plum Organics Plum Berry & Barley Organic Baby Food;
- Plum Organics Raspberry, Spinach & Greek Yogurt Organic Baby Food;
- Plum Organics Sweet Potato Mango & Millet Organic Baby Food;
- Plum Organics Zucchini Banana & Amaranth Organic Baby Food;
- Plum Organics Kale, Apple & Greek Yogurt Organic Baby Food;
- Plum Organics Kale, Sweet Corn & Quinoa Organic Baby Food;
- Plum Organics Green Bean, Pear & Greek Yogurt;
- Plum Organics World Baby Zucchini & Spinach with Pasta Marinara Organic Baby Food;
- Plum Organics Pumpkin, Pomegranate, Quinoa, and Greek Yogurt Mighty 4 Essential Nutrition Blend;
- Plum Organics Purple Carrot, Blackberry, Quinoa, and Greek Yogurt Mighty 4 Essential Nutrition Blend;
- Plum Organics Sweet Potato, Blueberry, Millet, and Greek Yogurt Mighty 4 Essential Nutrition Blend;

- Plum Organics Kale, Strawberry, Amaranth, and Greek Yogurt Mighty 4 Essential Nutrition Blend;
- Plum Organics Spinach, Kiwi, Barley, and Greek Yogurt Mighty 4 Essential Nutrition Blend;
- Plum Organics Mighty 4 Essential Nutrition Bar Blueberry with Carrot;
- Plum Organics Mighty 4 Essential Nutrition Bar Strawberry with Spinach;
- Plum Organics Mighty 4 Essential Nutrition Bar Pumpkin Banana;
- Plum Organics Blueberry, Pear, Sweet Potato, and Spinach Super Smoothie Organic Essential Nutrition Blend;
- Plum Organics Organic Teensy Fruits Soft Real Fruit Snacks Berry;
- Plum Organics Organic Teensy Fruits Soft Real Fruit Snacks Peach;
- Plum Organics Tots Fruit & Grain Mish Mash Organic Whole Grain Snack Blueberry Oats & Quinoa; and
- Plum Organics Yogurt Mish Mash Fruit & Veggie Yogurt Smoothie Purple Roots & Fruits.

Enclosed herein as Exhibit 1 are the product labels, nutrition facts, and ingredients of the Products.

Facts Giving Rise to Plum's Liability

Plum falsely and misleadingly labels the Products on their Principal Display Panels (PDPs)¹ as containing certain healthful, high-value ingredients, such as kale, quinoa, blueberries, and green beans, when, in fact, the Products are overwhelmingly composed of other less healthful, less-valuable ingredients, such as apple juice or apple puree, that are not identified at all on the PDPs.

Furthermore, the images on the PDPs reinforce the presence of the ingredients Plum identifies in the Product names, and the images fail to identify the presence of the more predominant, less-healthful ingredients.

Finally, in most cases, the high-value ingredients Plum prominently identifies, such as kale and quinoa, are, in fact, among the least predominant ingredients in the Products.

For all of these reasons, reasonable consumers who purchase the Products for their babies and toddlers fall victim to a bait and switch. Plum's actions are especially problematic because parents likely trust Plum more than other brands that they may scrutinize more closely, as Plum's labeling practices mislead consumers into believing Plum's Products are health foods by prominently using terms like "organic," "essential," "nutrition" and "whole grain," and phrases like "set them up for a lifetime of healthy eating."²

While all of the Products are mislabeled for similar reasons, they fit into six groupings: Baby Foods, Mighty 4 Essential Nutrition Blends, Mighty 4 Essential Nutrition Bars, Super Smoothie, Teensy Fruits, and Mish Mash. We discuss the Products in each grouping below.

I. Baby Foods

Plum Organics Blueberry, Parsnip & Buckwheat Organic Baby Food (Ex. 1 at 2) is a prime example of Plum Organic's bait and switch labeling tactic. Despite the label's prominent identification in the Product name, and in the images on the PDP of only blueberries, parsnips, and buckwheat, the Product consists principally of a far less nutritious, sweeter, and less expensive ingredient—apple puree.³ Indeed, despite being named and/or prominently illustrated on the PDP, blueberries and buckwheat are among the least predominant ingredients in the Product. (Ex. 1 at 2.)⁴

Similarly, Plum deceptively labels Plum Organics Kale, Apple & Greek Yogurt Organic Baby Food. While Plum identifies kale, an exceptionally healthful ingredient, first in the Product name and prominently illustrates kale on the front label, kale puree is actually among the least predominant ingredients in the Product. (Ex. 1 at 8.)⁵ Moreover, the yogurt is pasteurized and therefore contains none of the healthful live bacteria that yogurt is generally perceived as providing.

So, too, for Plum Organics Green Bean, Pear & Greek Yogurt Organic Baby Food (Ex. 1 at 10). Despite the label's prominent identification in the Product name, and in the images on the PDP, of green beans, green bean pure is among the least predominant ingredients in the

Apple puree, though unnamed on the PDP, is also the predominant ingredient in the following Products (named ingredients that are unexpectedly low on the ingredient list are identified in parentheses after the Product name): (i) Plum Organics Plum Berry & Barley Organic Baby Food (milled barley), (ii) Plum Organics Raspberry, Spinach & Greek Yogurt Organic Baby Food (spinach puree), (iii) Plum Organics Sweet Potato, Mango & Millet Organic Baby Food (milled millet), and (iv) Plum Organics Zucchini Banana & Amaranth Organic Baby Food (milled amaranth). (*Id.* at 4–7).

While Plum identifies quinoa, a nutritious ingredient that may be perceived as high-value, in the Product name and prominently illustrates quinoa on the PDP, milled quinoa is actually the second-to-last ingredient in the Product's comparatively extensive ingredient list. (Ex. 1 at 9.)

Product. (Id.)

Sweet potato puree is the most predominant ingredient in Plum Organics World Baby Zucchini & Spinach with Pasta Marinara Organic Baby Food (Italy). (Ex. 1 at 11.) The Product name, however, makes no mention of sweet potatoes, and the images on the label do not include sweet potatoes, either. (*Id.*)

II. Mighty 4 Essential Nutrition Blends

Following an identical pattern of misbranding are Plum's Mighty 4 Essential Nutrition Blends. Plum Organics Pumpkin, Pomegranate, Quinoa, and Greek Yogurt Mighty 4 Essential Nutrition Blend, for example, consists largely of something else—inexpensive and highly sweet fruit purees. (Ex. 1 at 12.) This is the same with Plum Organics Purple Carrot, Blackberry, Quinoa, and Greek Yogurt Mighty 4 Essential Nutrition Blend. (Ex. 1 at 13.) Purple carrot juice concentrate, despite being the first ingredient listed on the PDP, is one of the least predominant ingredients in the Product. (*Id.*)⁶

III. Mighty 4 Essential Nutrition Bars

Likewise, the filling in Plum Organics Mighty 4 Essential Nutrition Bar Blueberry with Carrot is *predominantly evaporated cane syrup* (a form of sugar), brown rice syrup (another form of sugar), and apple powder, and not blueberries or carrots, despite the Product's name. Further, the ingredient list is almost illegible given the style, size, capitalization and compression of the font. (Ex. 1 at 17.)⁷

IV. Super Smoothie

Plum Organics Blueberry, Pear, Sweet Potato, and Spinach Super Smoothie Organic Essential Nutrition Blend follows suit. Despite its name, with blueberry being the first ingredient mentioned, blueberry purce is among the least predominant ingredients in the Product. (Ex. 1 at

(Ex. 1 at 14.) Milled amaranth is one of the least predominant ingredients in Plum Organics Kale, Strawberry, Amaranth, and Greek Yogurt Mighty 4 Essential Nutrition Blend, which, again, is largely comprised of inexpensive and less nutritious apple purce. (*Id.* at 15.) Pear purce and banana purce, though unnamed on the PDP, are the predominant ingredients in Plum Organics Spinach, Kiwi, Barley, and Greek Yogurt Mighty 4 Essential Nutrition Blend, and milled barley is one of the least predominant ingredients. (Ex. 1 at 16.)

(Ex. 1 at 18–19.)

V. Teensy Fruits

Plum Organics Organic Teensy Fruits Soft Real Fruit Snacks Berry prominently identifies itself as "berry" and features images of a strawberry, raspberries, blueberries, and cherries on the PDP. Again, the top two ingredients in the Product are apple puree concentrate and apple juice concentrate, which are never mentioned on the PDP. (Ex. 1 at 21.)⁸

VI. Mish Mash

Plum Organics Tots Fruit & Grain Mish Mash Organic Whole Grain Snack Blueberry Oats & Quinoa fails to disclose that it is predominantly comprised of apple puree and banana puree. (Ex. 1 at 23.)

And, purple carrot concentrate is one of the least predominant ingredients in Plum Organics Yogurt Mish Mash Fruit & Veggie Yogurt Smoothie Purple Roots & Fruits, which consists predominantly of banana puree. (Ex. 1 at 24.)

In sum, by naming the Products after high-quality, nutritious vegetables, grains, and fruits and featuring those prominently on the Product labeling without disclosing that the actual percentages of many of those ingredients in the Product are low or even negligible and, by corollary, that the Products are largely comprised of far cheaper and less nutritious ingredients, Plum is misleading consumers.

Plum's Violations of State and Federal Law

Plum's representations about the Products discussed above are false, misleading, and deceptive. Consequently, the representations violate numerous consumer protection statutes, such as the District of Columbia's Consumer Protection Procedures Act, D.C. Code § 28-3901 *et seq.*, California's False Advertising Law, Cal. Bus. & Prof. Code § 17500 *et seq.*, Unfair Competition Law, Cal. Bus. & Prof. Code § 17200 *et seq.*, and Consumers Legal Remedies Act, Cal. Civ. Code § 1750 *et seq.*, and New York's Consumer Protection from Deceptive Acts and Practices Law, N.Y. Gen. Bus. Law § 349 *et seq.*, as well as the prohibition on breach of express

warranty in force in states throughout the country. Alternatively, Plum's misrepresentations give rise to liability for breach of quasi-contract under the laws of numerous states.

Plum's representations also render the Products "misbranded" under the Federal Food, Drug and Cosmetic Act, 21 U.S.C. § 301 *et seq.* (the "FDCA"), and the regulations the FDA has promulgated to implement it. Plum's violations of the FDCA and its attendant regulations parallel the violations of state law we identified above.⁹

Specifically, the FDCA provides that a food is "misbranded," among other reasons: if "its labeling is false or misleading in any particular," 21 U.S.C. § 343(a)(1),¹⁰ and if its label does not bear "the common or usual name of the food, if any there be," § 343(i)(1).

Labeling may be false and misleading where, as here, it misleads the consumer into believing an ingredient is prevalent in a Product when, in fact, it is not. If the proportion of an ingredient in a Product is material to the consumer's decision to purchase the Product, then the percentage of that ingredient must appear as part of the Product's name. Under 21 C.F.R. § 102.5:

The common or usual name of a food *shall include* the percentage(s) of any characterizing ingredient(s) or component(s) when the proportion of such ingredient(s) or component(s) in the food has a *material bearing on price or consumer acceptance or* when the labeling or the appearance of the food may otherwise create an erroneous impression that such ingredient(s) or component(s) is present in an amount greater than is actually the case.

21 C.F.R. § 102.5(b) (emphasis added); see also id. § 102.5(c) (requiring labeling in the common or usual name of the presence of characterizing ingredients that have a material bearing on price

or consumer acceptance).¹¹ In promulgating § 102.5(b) and (c), the FDA stated that the disclosure of the amount of a characterizing ingredient is a "material fact" within the meaning of 21 U.S.C. § 321(n) and that "[d]isclosure of this fact is often necessary for the consumer to choose between two competing products when the amount of the ingredient is important to the value of the food."¹² Further, the FDA explained that "a 'characterizing ingredient' which is required to be labeled by percentage is one whose proportion in the food has a material bearing on price or consumer acceptance or which a consumer might otherwise believe to be present in an amount greater than is actually the case."¹³

Here, Plum's Product labels violate 21 U.S.C. § 343(a)(1) and (i)(1) and 21 C.F.R. § 102.5(b) and (c). As discussed above, most of the Products fail to disclose the proportions of characterizing ingredients by means of a percentage declaration on the PDP where the proportions of these ingredients, whether kale, quinoa, blueberries, or the like, have a material bearing on price and consumer acceptance. The Products also fail to disclose the presence and proportions of other characterizing ingredients, such as apple puree, where the ingredients' presence and proportions have a material bearing on price and consumer acceptance. 21 C.F.R. § 102.5(b), (c).

Settlement Demand

In light of the foregoing, CSPI and Reese LLP invite Plum to resolve its illegal and deceptive advertising to avoid further legal action. CSPI and Reese LLP seek to prevent Plum from deceptively labeling and marketing the Products by misrepresenting the presence and/or proportions of the Products' ingredients on their Principal Display Panels. And, of course, adhering to honest marketing practices would only benefit Plum and its consumers in the long run.

Should Plum choose not to respond to the foregoing findings, CSPI and Reese LLP will pursue litigation seeking the following:

- Entry of a permanent injunction prohibiting Plum from expressly or implicitly making deceptive representations on the labels and in the marketing of the Products.
- Disgorgement of Plum's profits from the sale of the "Plum Organics" brand food Products at issue.

If Plum is willing to discuss a settlement or requires additional information about the claims documented herein, we welcome contact from counsel.


